## **Clean Sweep of the Great Miami River 2017**

### **Agreement to Participate – Release and Indemnification Form**

**I, the undersigned, for the duration of the event, agree to follow these instructions:**

- Do not disturb any drum containers – report their location to the coordinators.

- Use common sense about lifting heavy objects.
- Never work alone.
- Report any accidents or injuries to the coordinator immediately.
- Ask permission if entering private property identifying yourself as a Sweep Volunteer.

I also understand that the nature of this activity involves certain dangers and risks, and I voluntarily assume all risks of accident or injury.
